# **Business Higher National Diploma**

#### **Course Overview**

This is a two-year full-time university-level course awarded by De Montfort University (DMU). Over three terms per year, the programme brings together the practical and theoretical elements of management, marketing and finance and leads to a Higher National Diploma (HND) award. The overarching aim of the Business HND is to support students to acquire and develop the knowledge, skills, and behaviours necessary to work effectively, confidently, and responsibly within a wide range of business organisations. It provides students with an excellent grounding in a range of business areas. Whilst this course is taught at Leicester College, the diploma is affiliated to De Montfort University and with this you can enjoy the benefits of DMU's extensive library and student union at its campus in Leicester city centre.

#### What you will learn

You'll be provided with an excellent grounding in aspects of business which will give you the ability to critically evaluate organisations in terms of their key areas of business management, structures, functions, and processes. You will study modules in Business Management, Marketing, Accounting Budget Management and Human Resource People Management. <br/>

## **Entry Requirements**

Standard entry to this course requires a minimum of 32 UCAS in a level 3 qualification (i.e. A-Level, extended/subsidiary diploma, Access to HE or T-Level) in a related subject. You are also expected to hold GCSE English and maths at grade 4 (C) or equivalent. <br/>

#### **Course Fees**

If the course is longer than one year the total fees are for the first year only and further fees may apply in future years. All fees are based on a 'home' learner status.

#### **Course Progession**

Progression to the Higher National Diploma in the second year is dependent on your performance and engagement in year 1. <br/>
- I / Sor / Son successful completion of this HND, you can apply to 'top up' to the 3rd year of the BA (Hons) Business and Management at De Montfort University and also BA streams within the faculty. In order to do this, you will need to have achieved level 2 English and maths. You may also wish to inquire with other universities for your top-up studies.
